Section 1. The November Levy Resolutions, pertaining to the submission of the question of an additional, 4.7-mill, current expense tax levy in excess of the ten-mill limitation, to run for a continuing period of time, that was to be submitted to the electors of the School District at the November 4, 2014 election, as they were adopted, be and the same are hereby repealed.

Section 2. In accordance with the repeal of the November Levy Resolutions as set forth in Section 1 hereof, the Ashtabula County Board of Elections is hereby requested, authorized and directed to remove the question submitted by this Board of said tax levy from the November 4, 2014 ballot.

Section 3. The Treasurer of this Board is hereby authorized and directed to certify immediately a copy of this Resolution to the Ashtabula County Board of Elections. The Treasurer and any other School District official are further authorized and directed to take any and all actions and do any and all things that are required to effectuate the purpose of this resolution, being the removal of the question of the aforesaid tax levy from the November 4, 2014 ballot.

Section 4. This Board finds and determines that all formal actions of this Board concerning and relating to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all requirements of law.

Section 5. This resolution shall be in full force and effect from and immediately upon its adoption.
