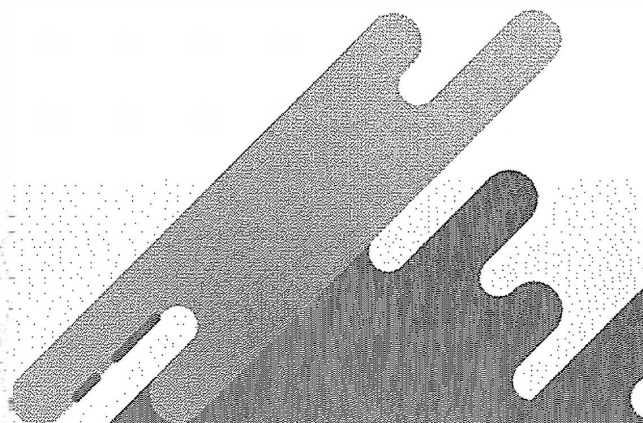
II. PURPOSE AND SCOPE

Buckeye Local School District

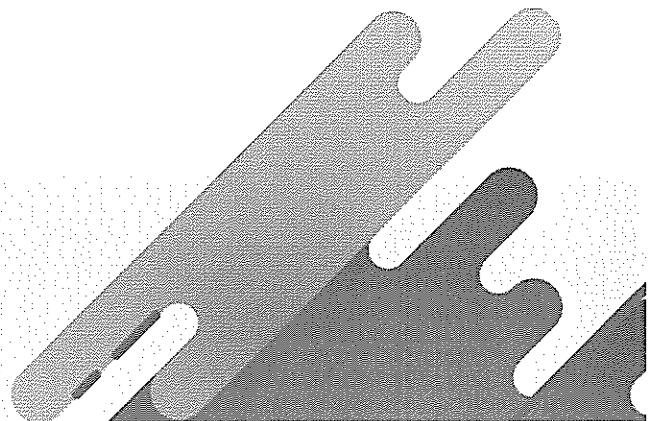
- Provide transportation to and from school
