- Beginning Thursday, April 9, 2015, the work day for teachers will be extended 15 minutes before the current day and 15 minutes after the current day. This will continue to the final instructional day, Thursday, June 4, 2015. This is the equivalent of four (4) make-up days.
- Friday, June 5, 2015 will be converted from a Teacher Report Day to a professional development day. This day shall be five (5) hours in length.
- Monday, June 8, 2015 will become a Teacher Report Day. This day shall be five (5) hours in length. This is the equivalent of one (1) make-up day.
- Should additional calamity days occur during the 2014-15 school year, additional work days will be added.
